Bhavan Fee Payment Notice

Subject: Payment of Bhavan Fees for Even Semester - January 2020-21 by Final year students residing at Bhavan.

1.0 Universities on Campus operations have been closed since 16th March, 2020 when the Government of India announced a countrywide lockdown as one of the measures to contain the COVID-19 outbreak. Now, as per the directives of Government, GSFCU is reopening On Campus education / activities for the final year undergraduate students and post graduate students who are desirous of availing this option.

Students opting for On Campus teaching and already residing in the Bhavan shall also be allowed to re occupy the Bhavan subject to adherence to Government guidelines.

In view the students who has consented for On Campus option and is to occupy the Bhavan, is required to pay the proportionate Fees for Lodging and Boarding facility as detailed hereunder.

2.0 During the period from 16.03.20 to 30.06.20 (3.5 months), students did not avail the Bhavan facility and hence GSFCU management vide Circular dated 20th July 2020 had decided and informed that the proportionate amount for Lodging Fees already paid by students earlier shall be adjusted in the next Semester on restart of University / Occupying the Bhavan.

3.0 The regular Bhavan Fee structure at GSFCU is as under.

Bhavan Fee Structure per semester

Bhavan Boarding fees	Rs. 27500 /-
Bhavan Lodging Fees	Rs. 12500 /-
Total Bhavan Payment	Rs. 40000 /-



Considering the period of current semester from 18.01.21 to 30.06.21 and after adjusting the amount as per circular dated 20th July 2020 referred above, the actual payable Bhavan Fees for this Semester Jan'21 to June'21 works out as under.
