



## Notice-Bhavan Occupant

**Date: 18.02.2021**

- 1.0 On campus operations at Universities were suspended since 16th March, 2020 upon announcement of lockdown by Government of India as one of the measures to contain the Covid- 19 outbreak. Now, as per the directives of Government, GSFCU is reopening on campus education / activities for the 1st year students & for the final year undergraduate and post graduate students at their option.
- 2.0 Students opting for on campus teaching and existing resident in the Bhavan shall also be allowed to re occupy the Bhavan subject to adherence to government guidelines.
- 3.0 In view of above, it will be required to allocate bhavan admissions to existing bhavan resident students first on their conformation and allocate balance rooms subsequently to newly admitted students. In view kindly confirm your interest to continue with the bhavan admissions. To secure your admission, kindly pay a token amount fees of Rs. 5000/- . This token amount of fees is for existing students of bhavan resident to confirm their occupancy in bhavan, which will be non-refundable. Balance amount due shall become payable before actual occupation of the bhavan on start of on campus teaching.
- 4.0 It is necessary to adhere to the government guidelines for precautionary measures while starting the activities and also for the services like Bhavan, Transportation etc being provided by the University.
- 5.0 Interested students to register for availing Bhavan services, please follow the steps mentioned below:
  1. Login with your DCS credentials
  2. Go to main menu & click on the all fees
  3. Under that please select Bhavan Reservation Charges
  4. Please fill your bank details (if required)
  5. Press submit button
